Inspection Results Summary:

- Haul road from site entrance through to office clean. HGV's visiting principally Bushcade livery coming in from Beaulieu area.
- Compensation area not visited as no works carried out since last visit. No evidence of cattle grazing on land.

- Within southern void levels have been brought up to just below topsoil level along western side. Final marker pegs about 0.5 ish short of final level.
- Grading of material being undertaken in south eastern void corner. Overburden being
 utilised from bunding on eastern side of northern void location. Grading also
 undertaken along northern edge of void adjacent haul road. Stockpile of
 soil/overburden stockpile still present just off haul road lying in a north south
 orientation through southern void.
- Previous recorded that it was estimated two/three months to complete infilling to subsoil level. KP considered infilling not likely to be completed now this year.
- Approach to bridge continues to have metal fencing to filter pedestrians past bridge entrance and along public right of way. Further steel fencing runs either side of the bridge between it and the surrounding vegetation. Skip remains positioned near bridge this appeared to have cardboard material visible inside.
- Reptile fencing along eastern edge of southern void and within the former processing plant area now mostly obscured by vegetation. This needs cutting back to allow effectiveness of fencing to be achieved.
- KP advised that JKS presence eon site now terminated as company appears to have gone out of business. Site offices empty; no site activity other than for front loader shifting processed onsite material into stockpiles within the recycling area. Crushers and hoppers parked up throughout site.. Stockpiles quite high through out site but appear to be at permitted height when viewed against visual site markers.
- KP advised that the contract/future site presence of the stocks etc under active consideration within the company.
- Row of ISO containers, and mobile crusher unit, continue to be sited to the east side of recycling parcel and adjacent the site offices. Metal fencing stored on top of containers.
- KP advised that Bioscan had been on site recently and that membrane now ready in next few weeks to be layed within 4 of the scrapes/low areas identified for holding water.
- A number of low mounds about 1 -1.5 metres high of what appears to be vegetation and top layer scrap material located north of the former processing plant footprint awaiting to be lifted and used as cover for the hibernaculams located immediately behind the stockpiles and comprising stock of branches and roots to house wildlife. This work to be carried out by onsite staff.
- The two short sections of insitu concrete paving along the old processing plant haul road still remain. KP advised that Bioscan asked for this to be left insitu and buried.
- Conservation area continues to establish with ground vegetation..
- Tipping stopped in northern void whilst the aforementioned overburden removal being undertake with 360 excavator and 2 dumptrucks.
- Access tracks remain in place along both the north eastern and south eastern banks allowing access to the floating electric pump and monitoring locations.
- Most recent of the Newt ponds holding water. Tree planting undertaken on failures in planting areas have visible herbicide spraying around their base. Grass growth within

the fenced areas as well as across the wider field is long. Recent presence of sheep evident across the open field.
