Introduction

Allowances paid to members of Essex County Council are governed by the Local Authorities (Members' Allowances) (England) Regulations 2003. These regulations require the County Council to make a scheme of allowances which provides for the payment of an allowance in respect of each year to each member of the authority. This is known as the Basic Allowance.

The regulations also say that the scheme may provide for the payment of a Special Responsibility Allowance ('SRA') to members who have allocated to them special responsibilities as defined in the Members Allowance Scheme.

Finally, the regulations also say that the scheme may provide for payment of a Carer's Allowance, a Co-optees Allowance and a Travel and Subsistence Allowance which may be claimed for expenses when undertaking duties approved by the Council.

The County Council has adopted a Members Allowance Scheme which allows for all of these types of allowances to be paid in certain circumstances – as set out in the scheme. The Scheme is published on the County Council's website as part of the constitution.

When making or amending a scheme of allowances the Council must have regard to recommendations made to it by an Independent Remuneration Panel. The most recent recommendations of the panel were made in July 2022 and have also been published. As a result, there were some increases to Special Responsibility Allowances effective 1 September 2022 and these are reflected overleaf. Furthermore, an annual adjustment is made in line with an index agreed by Full Council in July 2022 which is based on the Office of National Statistics Public Sector Pay Index.

The Council is required to maintain records of all allowances paid to its members and, at the end of each year, to publish the total sum paid to each member in respect of each of the above types of allowance.

Accordingly, the amount of allowances due to each member of the County Council with respect to the period 1 April 2023 to 31 March 2024 are shown in the table below.

It should be noted that entitlement to a Special Responsibility Allowance varies according to role and may change during the year. Some members may voluntarily forego part or all of the allowances to which they are entitled. Other factors can also affect the amount paid. The details of such variations are provided in the table.

- ** A fee is paid to Mr N Hodson and Mr J Swan who are independent persons appointed under the Localism Act 2011 to advise on standards matters.
- Note 1: Councillor Reid was elected as a County Councillor on 4 May 2023. Her Basic Allowance figure is prorated accordingly.
- Note 2: Councillor Blackwell elected to forgo the last two annual increases in the Basic Allowance. Councillors Bentley and Newport elected to forgo one of them hence why their figures are also different.
- Note 3: Some members will have been paid less than the full year Special Responsibility Allowance having served for less than 12 months during the reporting year. Entitlement to a Special Responsibility Allowance varies according to role and may change during the year. There were increases made to Special Responsibility Allowances effective 1 September 2022. Since then, there has been an annual adjustment made in line with an index agreed by Full Council in July 2022 which is based on the Office of National Statistics Public Sector Pay Index
- Note 4: Effective September 2022 a new Special Responsibility Allowance was introduced for the opposition leaders who were not leading the largest opposition group there was already a Special responsibility Allowance for the leader of the largest opposition group.
- Note 5: Figures stated are payments made in the reporting year. Whilst members have been encouraged to claim by the end of the reporting year for all expenses incurred in the reporting period, there may still be a minimal number of expenses incurred during the reporting year that were not paid until the following reporting year.
- Note 6: Councillor Luke Mackenzie sadly died on 14 March 2024 and his allowance was pro-rated accordingly.
- Note 7: Councillor Eddie Johnson resigned on 15 March 2024 and his allowance was pro-rated accordingly.
