Actions from last site visit:

- To check what the commitment was for planting provision on/near perimeter ditches.
 Update: Options and programme for North eastern planting areas to be considered at next meeting.
- Planting areas to be advised on by County Landscape Officer at next meeting. Update: This will be addressed in Spring.
- Useful for clarity on method of weed suppression on tree planting locations. Update: VH confirmed mulching/spot weeding and strimming.

Inspection Results Summary:

- Site access clear and unobstructed. VH raised landowners wish to continue hedgerow planting across front of entrance up to green metal posts and just in front of wooden fence.
- Grass short throughout site.
- Site walked anticlockwise.
- Eastern tree planting area now complete and SM advised that landowner would have access to this land. Potential for sheep grazing.
- Trees not fully inspected. SM noted one hare found in one of the planting parcels. Rabbit guards are in place around the outside of the three planting parcels. Evidence of rabbits attempting to dig under fencelines.
- Northern unworked areas still in agricultural use.
- Some wind blow of tree tubes on northern perimeter. Ponding of water around the north eastern tree plantings. This area and potential remedial measures to be considered next visit in consultation with Landscape Officer.
- Hedge translocation area had been trimmed down and site operator was working along hedge doing pruning.
- Archaeological investigations complete for Phase 2.
- Extraction continuing in Phase 1. Sub Phase 1c and 1d comprising western half of the larger phase will be next extraction series. Phase 1c has had some mineral extracted through as this was the base of the former silt lagoon. SM intention to align both c and d faces before extraction continuing westwards
- Lagoon in Phase 1a has now stabilised its water level.
- Processing plant location quiet with machinery being hosed down. No mineral being removed and the site to be working off stockpiles.
- Lagoon system operational.
- No HGV's visiting during monitoring period.
