#### Actions from last site visit:

- Monitoring of haul road and site entrance cleanliness. Update: Entrance clean at time
  of visit.
- Clearance of spoil from site entrance hedgerow. Update: Work around drainage point has taken place and spoil has been removed from entrance point. Still awaiting concreting in of the drain.
- Clearance of spoil beneath oak tree canopy and removal of spoil where it has infringed norther fence perimeter. Regrading of the banking to marry in with regraded slopes elsewhere on perimeter. **Update: Grading back undertaken.**
- Stockpiles through out site to no more than permitted levels. Update: Operator to action.
   Stockpiles have been reduced in height and extent since last visit although rear most stockpile has had fresh tipping on top. DN advised to lower the top down to the next bench height.
- Material which has slumped into the third party land needs to be removed. Update: Still to be actioned.

## **Inspection Results Summary**

Site mostly quiet at time of visit. Machinery working in Phase 1 ADT and Excavator removing/spreading inert material from eastern most stockpile down through the haul road and base of remaining void to act as cover to the liner over the winter period.

On eastern end of Phase 111 stockpiles of various infill material and soils remain. Soil mound alongside haul road and closest to public footpath has road material debris tipped on its flanks. This is contaminating the soil resource and care should be taken on preventing this occurring and the material removed.

Public footpath warning signs at the vehicle cross over point have been either removed/destroyed and need replacing.

Kept on from last 2 monitoring visit reports - Material spill over onto third party land can be observed from public footpath that runs from road side restaurant northwards through eastern side of main site parcel. Removal of the spill material has been picked on in previous monitoring report.

Internal haul road along southern perimeter has been graded. Care needs to be taken that scrapped surface material not deposited against trees/hedgerows which has occurred in places and needs to be rectified.

One void remains now within central half of main site. This area awaiting clearance of the liner report to the Environment Agency and then, end of January infilling anticipated to commence with stockpile alongside its western flank being placed into void.

Northern boundary has water logging in the ditches. Fencing breached in one place; Evidence of motor bikes tracking into site and over storage mounds.

Part of western northern flank facing the wood has now been regraded.
